John Albinger – Welcomes & opened the meeting, distributed anti-trust statement which was signed by all attendees.

Jim Randolph— informed the committee about what is new in the association and gave them a legislative update.

Theron Tobolski— talked about the forthcoming Regional Promotion Groups, makeup and function of the newly formed Regional Promotion Group.

A.J. Bimrose, Chairman of the Technical Committee – conducted the meeting. Items addressed:

#### 1. IDOT

Doug Anderson, Headwaters addressed the issue of testing issues and future availability of fly ash.

Lee Crisp, Sky Cement Company addressed the issue of testing issues and future availability of slag.

#### 2. FAA and IDA

New FAA specifications were distributed and discussed. Implementation of this specification
would impose hardships on both the aggregate and ready mix industries. IAAP, IDA and IRMCA
are in discussion with FAA.

### 3. General Industry- issues and actions:

- IRMCA policies, alerts and TIPs were distributed and discussed.
- Residential driveway mixes and specifications were discussed.
- Action: Copies of IRMCA's Specifications for Residential Exterior Flatwork will be sent to all committee members for review. After the suggested revisions it shall be revised and distributed to all association members.
  - Concrete testing onsite were discussed.
- Action: John Albinger will write an IRMCA policy statement and a form to be utilized by the producer to record such testing deficiencies.
  - Contractor relationships Theron Tobolski informed the committee about the establishment of Regional Promotion Groups and a "Concrete 101" class.

#### 4. Technical Liaison Committee
