State Update

The Illinois Department of Transportation announced the Multi-year Program last Friday. IDOT will spend \$34.6 billion to improve roads, bridges, transit, rail, airports, and ports over the next six years. The program will spend \$6.36 billion on highway reconstruction, \$6.4 billion for bridge improvements, \$2.03 billion for strategic expansion, \$2.48 billion for engineering and land acquisition, and \$1.55 billion for safety and systems modernization. The Illinois Department of Transportation recently released a new Illinois Aviation System Plan, identifying the short- and long-term needs and goals of the state's airports. The Illinois Aviation System Plan focuses on individual airports and the aviation system as a whole, looking at ways they can support economies throughout the state, improve quality of life and boost mobility. More

Federal Update

The U.S. Department of Transportation recently awarded more than \$2.2 billion in grants from the Rebuilding American Infrastructure with Sustainability and Equity or RAISE program to help urban and rural communities move forward on projects that modernize roads, bridges, transit, rail, ports, and intermodal transportation systems. Projects in Harvey, East Moline, Chicago, and Springfield received funding. More
